“Flat Fee” rentals

VIOLIN: all sizes	\$59 for 3 month	Includes \$20 maintenance and replacement fee
VIOLA: all sizes	\$59 for 3 month	Includes \$20 maintenance and replacement fee
CELLO: all sizes	\$73 for 3 month	Includes \$25 maintenance and replacement fee

Requirements: In order to rent from us you will need a valid driver’s license, a major credit card (or some other proof of credit, like a car loan or home mortgage...)

Also, the first 3 (three) month are due when you get the instrument.

Service:

For service just come by our shop. Call our shop first, to make sure I did not step out and I will be there!

Terms and conditions:

RENTAL FEE:

The rental fee is comprised of the rental price and the insurance, which includes maintenance and replacement of the instrument and is due upon receipt of the outfit. The rental fee does **not** include rosin and strings.

The rental fee is to be paid within 10 (ten) days of the due date, which will be indicated on your bill.

If you no longer want to rent the instrument you will be required to return the instrument to us within 10 days the due date. Payment of the rental fee will automatically continue your rental contract for the rental period paid for.

You are entitled to keep the instrument until the last day of your rental period, which corresponds to the due date indicated on your bill. There is a \$20.00 fee for any check or charge being returned to us or denied for any reason.

If you should decide to return the instrument before the due date, there will be no pro rating of the last payment made.

RENTAL CREDIT:

100% of the rental fee you are paying can go towards and up to 50% of the purchase price of any instrument in our shop, new or used. If you want to buy your rental instrument, you can do that too.

The maintenance and replacement fee - \$20 for violin/viola and \$25 for cello – do not accumulate as credit.

There is no time limit on how long you can accumulate the rental credit.

OVERDUE PAYMENT:

By signing a rental contract you are allowing us to make a withdrawal from your credit card in the amount owed if the instrument is not returned, or payment is not received within 10 days of the due date.

In case no withdrawal can be made, your account will accumulate interest of 2% and be handed over to our collection agency. Any fees incurred will be your responsibility. A late charge of \$10.00 will be charged on all accounts that are 30 days or more past due.

INSURANCE:

The outfit is insured against fire and theft, as well as normal wear and tear.

In case the outfit is lost due to fire or theft a police report must be made out.

DAMAGE TO RENTAL OUTFIT:

Any damage done to commercial outfit will be repaired at my expense.
